#### Overview

The Hampton School District, SAU 90 seeks to take advantage of E-Rate funding once again for the 2017-18 FY. As part of a recent newly approved building project in district, we will be adding new learning space at our Hampton Academy Middle School.

As part of this new additional learning space and the refurbishment of existing space we will be needing some new and additional networking equipment. The equipment consists of some fiber cabling runs installed, new access points in new locations and switches to help control these new access points, new switches for new drops in the new locations and cabinets to store some of this equipment in. We will also need to finish off the upgrade to our existing network by replacing one old rack cabinet both at Hampton Academy and one at the Centre School. We will also need to purchase one additional Dell N2048 switch for drops at Centre School so to take full advantage in every room of our new fiber network in that building.

We plan to purchase 2 fiber cabling runs containing 12 strand dual mode fiber to run from our MDF to two of our IDFs with installation so to maximize the new speeds provided by our new switches and Fiber in district within this building. We will need installation for these fiber runs as well. The new building will contain new classrooms, a gymnasium, office spaces and common meeting areas. We are seeking to purchase access points to cover these new areas.

We plan to purchase 3 Dell N2048 switches for these new areas for new drops, 1 Aerohive SR2024 switch to manage the new Aps and up to 10 Aerohive 230 APS APs, 11 Aerohive 130 APS APs and up to 2 exterior Aerohive 1130 APS APs for an exterior learning space being developed. We will also need to purchase 1 APC battery for backup purposes for our network. This 1 APC SMT1500RM 2U UPS will be used to replace a smaller non-rack mounted UPS currently being used to back up our network.

All of this equipment will need to be housed in a new location. We plan to also purchase 1 Dell Rack Cabinet, a Dell Netshelter SX42U, to use in the IDF at Hampton Academy in the newly refurbished IDF room.

We will also need to purchase one additional Dell Netshelter SX42U cabinet to replace a cabinet that has become too small to use at our Centre School.

We are seeking to add a Network Link Balancers equivalent to an Elfiq LBX1120 Bundle to our network. These are Layer-2 devices are typically deployed outside of the firewall for a seamless and transparent integration (bump-in-the-wire). The company's link balancing solutions include the innovative LBX and VLBX families. All Link Balancers proposed should be designed to proactively manage bandwidth from multiple ISP or private links, in an active-active configuration.
